


The MasterEmaco family of free flowing micro concretes has been formulated to be in a confined form environment during placement. The MasterEmaco products all have a dual shrinkage compensation system built into them. The first stage compensates for shrinkage in the plastic state and the second stage compensates for shrinkage in the hardened state.


The only exception to this rule is in a balcony edge detail or a window return detail. In both of these cases it is acceptable to have an open top area, not exceeding 12 inches in width, refer to ACI 308 Standard for proper curing procedures. Both products are capable of full depth placement, the only limiting factor is the minimum depth requirements. The MasterEmaco S 440MC has a minimum depth of 3/4" whereas the MasterEmaco S 440CI has a minimum placement of 2". Aggregate extension should never be done in the field.
