Treatment of Expansion Joints on Parking Structures

There have been several recent inquiries regarding the recommended construction detail for expansion joints and our traffic bearing membrane systems MasterSeal Traffic 1500 and MasterSeal Traffic 2500.

There are two items we will discuss in this bulletin:

- 1. What are the joint dimensions BASF Construction Systems recommends in order for the application to be covered by our warranty?
- 2. What is BASF Construction Systems recommendation on applying our deck membranes over sealant joints?


Item 1

Joint dimensions should be as stated in our literature for MasterSeal NP 1 and NP 2 (and SWRI guidelines). This means that in order to achieve the joint movement capability BASF Construction Systems states in our literature, the joint sealant should be applied at a depth of one-half of the width of the joint, with a maximum depth of 1/2 inch. This depth is measured from the top of the backer rod to the lowest point on the top surface of the sealant bead. This is extremely important if the sealant is being tooled to have a concave surface.


If the industry recognized joint width to depth requirements are not met, BASF Construction Systems cannot warrant the movement capability of the sealant.

Item 2

MasterSeal Traffic 1500/2500 may be applied over a sealant joint up to 1 inch wide as stated on the technical data guide. Joint preparation. must be completed as per the product data guide recommendations. For joints over 1 inch, the MasterSeal Traffic 1500 should be terminated at the edge of the joint. Follow the recommendations in the product data guide for this detail.
