A continuously insulated stucco system featuring Finestop RA/RS/VB air/water-resistive barrier

#### **DESCRIPTION**

Finestone Platinum CI Stucco Plus is a continuously insulated stucco system that provides a variety of rigid insulation board options to optimize thermal performance. Acceptable rigid insulation boards include EPS, Neopor, XPS and Polylso for ease of design to ensure energy code compliance.

The system uses Finestoneliquid applied air/water-resistive barriers that provide a premium level of protection of the sheathing and cavity against moisture and air intrusion. Optional Finestone Base Coat and DiamondShield reinforcing mesh are available for superior crack suppression.

Finestone Platinum CI Stucco Plus offers design flexibility, aesthetic appeal and energy savings. Finishes are available in a limitless color selection. Performance enhancement options include increased resistance to dirt pick-up and mildew, and specialty finishes that create stone-like, metallic or mottled stucco appearances.

Finestone Platinum CI Stucco Plus has passed rigorous tests including Full-Scale Fire, Radiant Heat, Wind-Load, and Water Resistance. The system features easy installation, proven durability and low maintenance.

### Apply the system directly to the following acceptable substrates:

- ASTM C1177 type sheathings, including DensGlass<sup>™</sup> exterior sheathing, eXP<sup>™</sup> sheathing, GlasRoc<sup>®</sup> sheathing, Securock<sup>™</sup> glass-mat sheathing, Weather Defense<sup>™</sup> Platinum sheathing, and GreenGlass<sup>®</sup> sheathing
- PermaBase<sup>™</sup> cement-board by National Gypsum and other cement-boards (ASTM C1325 Type A Exterior)
- Untreated Exposure I or exterior plywood sheathing (grade C-D or better)
- Untreated Exposure I OSB
- Huber Zip Sheathing (sheathing only)
- Gypsum sheathing (ASTM C79/ASTM C1396)
- Poured concrete/unit masonry

#### **USES**

For exterior walls in new and retrofit commercial, institutional and residential construction when a continuous high effective R-value is needed to meet energy or eco-efficiency standards, and/or when a rainscreen is desired or required to satisfy code issues related to drainage.



#### **DESIGN CONSIDERATIONS**

- Maximum allowable deflection L/360, based on structural properties only.
- The design wind load shall not exceed the system's allowable wind load as stated in applicable code reports.
- Details shall conform with FinestoneWall Systems recommendations and shall be consistent with the project requirements.
- Control joints and trim accessories required. Control joint placement is required in the Finestone Platinum CI Stucco Plus wall system every 144 ft<sup>2</sup> per ASTM C1063.
- Consult the framing and sheathing manufacturer for design and application considerations.

- Expansion joints are required in the system where they
  exist in the substrate, where the system adjoins dissimilar
  construction, at changes in substrates and at floor lines in
  multilevel wood frame construction.
- System shall terminate at expansion joints.
- Sealant joints shall be detailed and installed per sealant manufacturer's recommendations.
- A minimum 6:12 slope is required on all horizontal surfaces greater than 1".
- Backer rod, sealant and flashing are required at door and window openings.

- 5. Maximum 3-inch thickness XPS, ASTM C578 Type IV or Type X (must be ASTM E84 Class A)
- 6. Maximum 3-inch thickness, Atlas EnergyShield Pro
- 7. Maximum 3-inch thickness, Atlas EnergyShield Pro2

- 8. Maximum 3-inch thickness, Hunter Xci Class A
- 9. Maximum 3-inch thickness, Hunter Xci CG
- 10. Maximum 4-1/4-inch thickness, Hunter Xci Ply (maximum 3-1/2-inch foam, maximum 3/4-inch plywood)
- 11. Maximum 3-inch thickness, Carlisle R-2+ Sheathe, R2+ Mat or R2+ Silver
- 12. Maximum 3-inch thickness, unfaced noncombustible insulation (e.g. mineral wool)

Note: Interior sheathing must be 5/8" type X gypsum wallboard for all CI Stucco systems
