4" Sheathing Fabric: 101.5 mm x 54.8 m (4" x 180') roll. Weight is 83 g/m² (2.45 oz/yd²). 6" Sheathing Fabric: 152.4 mm x 54.8 m (6" x 180') roll. Weight is 83 g/m² (2.45 oz/yd²). 9" Sheathing Fabric: 228.5 mm x 54.8 m (9" x 180') roll. Weight is 83 g/m² (2.45 oz/yd²).

DESCRIPTION

Reinforced non-woven polyester fabric designed for use with Finestop RA, Finestop RS or Finestop VB air/water-resistive barriers. Listed in ICC-ES evaluation reports ESR-3209 and ESR-3310. Tested with Finestop RA, RS or VB in accordance with ICC-ES Acceptance Criteria AC212 for water-resistive barrier coatings, AC 148 for flexible flashing and ASTM E2357 for air barrier assemblies.

USES

For above grade use with Finestop RA, RS or VB air/water-resistive barriers. 4", 6" or 9" Sheathing Fabric reinforces Finestop RA, RS or VB over acceptable rough openings, sheathing joints and at transitions.

LIMITATIONS

- 1. Protect Sheathing Fabric during transportation and installation to avoid physical damage.
- 2. Store Sheathing Fabric in a cool, dry place protected from exposure to moisture.
- Reference Finestop RA, RS or VB product bulletin, specifications and details for complete information on installation.
- 4. Apply at temperatures 4 °C (40 °F) and higher (if LT Additive is used with Finestop RA or Finestop VB, application temperature can be lowered to -4 °C (25 °F).

APPLICATION:

Apply mixed Finestop RA, RS or VB at all sheathing joints, terminations, inside and outside corners and rough openings. Immediately place and center 4", 6" or 9" Sheathing Fabric over wet Finestop RA, RS or VB, embedding and completely saturating Sheathing Fabric. Ensure Sheathing Fabric extends evenly on both sides of the sheathing joint. Lap Sheathing Fabric 63.5 mm (2 1/2") minimum at intersections. Allow to dry to the touch before applying Finestop RA, RS or VB to entire wall surface. If spraying Finestop RA, RS or VB "wet on wet" application is acceptable.
