EZ Grip

Fast setting dry-mix polymer adhesive

PACKAGING

22.6 kg per 19-liter pail (50 lbs per 5-gallon pail)

COVERAGE

(Approximate) 25.5–30.1 m² (275–325 ft²) per pail

DESCRIPTION

Water-based, non-cementitious, translucent white adhesive, ready to use directly from the pail.

USES

1. For use with the Senerflex Wall System to adhere expanded polystyrene insulation board to the following acceptable substrates: ASTM C1177 type sheathings, including DensGlass™ exterior sheathing, eXP™ sheathing, GlasRoc® sheathing, Securock™ glass-mat sheathing, Weather Defense™ Platinum sheathing, GreenGlass® sheathing, PermaBase™ cement-board by National Gypsum and other cement-boards (AS™ C1325 Type A Exterior), Untreated Exposure I or exterior plywood sheathing (grade C-D or better), Untreated Exposure I OSB, gypsum sheathing (ASTM C79/ASTM C1396), poured concrete/unit masonry.

2. Used with Pebbletex Pressure Equalized Design to coat both edges of all closure blocks. Note: EZ Grip is not acceptable for adhering EPS to EPS in any application or for embedding mesh in any application.

MIXING

- Mix the contents of the EZ Grip pail with a low speed drill and paddle mixer until thoroughly blended
- 2. Additives are not permitted.
- 3. Close container when not in use.
- 4. Clean tools with soap and water immediately after use.

APPLICATION

Apply mixed EZ Grip to entire surface of insulation board using a stainless steel trowel with 5 mm x 5 mm (3/16"x 3/16") notches spaced 5 mm (3/16") apart. Additional EZ Grip may be required over uneven substrates to ensure proper adhesion occurs. During the application process, periodically check the EPS insulation board for proper adhesion and apply additional EZ Grip as needed.

Note: The ribbon & dab method is not an acceptable method when using EZ Grip.

LIMITATIONS

- 1. Protect Finestone materials during transportation and storage.
- 2. Store Finestone materials in a cool, dry place protected from freezing. Store at no less than 4 °C (40 °F). Protect from extreme heat and direct sunlight. Shelf life is two years when unopened and stored as directed.
- 3. Do not apply Finestone materials in ambient temperatures below 4 °C (40 °F). Provide supplementary heat during installation and drying period (at least 24 hours after installation and until dry) when temperatures less than 4 °C (40 °F) prevail.
- Do not apply Finestone materials to frozen surfaces.
