

- 1) SHEATHING FABRIC IS EMBEDDED IN SENERSHIELD—R AT SHEATHING JOINTS. SHEATHING FASTENERS ARE SPOTTED WITH SENERSHIELD—R.
- 2) APPLY SENERSHIELD-R TO SHEATHING SURFACE UNIFORMLY AT 10 MILS WET.
- 3) SENERGY BASE COAT IS MIXED AT THE TIME OF USE PER SENERGY INSTRUCTIONS WITH PADDLE AND DRILL TO A HOMOGENEOUS CONSISTENCY.
- 4) SENERGY BASE COAT IS APPLIED VERTICALLY TO THE BACK OF THE EPS INSULATION BOARD USING A 1/2" X 1/2" NOTCHED TROWEL HAVING 2" FLAT SEGMENTS BETWEEN NOTCHES.

- 6) ALL STEEL STUDS SHALL BE STRUCTURAL WITH 1 5/8" MIN FLANGE WIDTH AND HAVE A MINIMUM YIELD STRENGTH OF 33000 PSI








#### WINDOW JAMB DETAIL (FLUSH)




KICKOUT FLASHING DETAIL
