

APPLICATION NOTES

- 1) APPLY 2 COATS OF SENERSHIELD-R TO CMU SURFACE UNIFORMLY AT 10 MILS WET EACH. ALLOW FIRST COAT TO DRY PRIOR TO SECOND COAT APPLICATION.
- 2) SENERGY BASE COAT IS MIXED AT TIME OF USE PER SENERGY INSTRUCTIONS WITH PADDLE AND DRILL TO A HOMOGENEOUS CONSISTENCY.
- 3) SENERGY BASE COAT IS APPLIED TO THE BACK OF THE EPS INSULATION BOARD USING A 1/2" X 1/2" NOTCHED TROWEL HAVING 2" FLAT SEGMENTS BETWEEN NOTCHES.
- 4)MIAMI-DADE COUNTY APPROVED EPS INSULATION HAS A DENSITY OF 1 PCF AND IT SHALL BE APPLIED HORIZONTALLY IN A RUNNING BOND PATTERN STAGGERING VERTICAL JOINTS AND CORNERS.
- 5) AFTER BASE COAT IS DRIED AND INSULATION BOARD IS RASPED TO A SMOOTH SURFACE, A LAYER OF SENERFLEX BASE COAT IS APPLIED TO THE EXPOSED SURFACE. FLEXGUARD 4 REINFORCING MESH IS EMBEDDED IN THE WET BASE COAT BY TROWELING FROM THE CENTER OUT. ALL EDGES ARE LAPPED 2 1/2 INCHES.
- 6) SENERGY FINISH IS AN ACRYLIC BASED TÉXTURED EXTERIOR COATING READY MIXED FROM THE FACTORY. IT IS APPLIED WITH A STAINLESS STEEL TROWEL AND FLOATED TO A DESIRED TEXTURE.












TYPICAL WINDOW SILL FLUSH







TYPICAL KICKOUT FLASHING DETAIL


