

MasterEmaco A 400

Liquid additive SRA (shrinkage reducing agent) for the packaging of cement-based mortars expansive to the air and which allows to improve the curing.

MATERIAL DESCRIPTION

MasterEmaco A 400 is a special liquid additive specially designed for expansive air-based and premixed cement-based mortars, which improves curing and reduces shrinkage in the plastic and hygrometric phase.

MasterEmaco A 400 does not contain chlorides.

FIELDS OF APPLICATION

MasterEmaco A 400 can be added to repair mortars and for structural reinforcement and, in particular, in cases where the design requires a control of medium and long curing cracking phenomena.

The addition of MasterEmaco A 400 is recommended above all for restorations with large surfaces exposed to the air and in the absence of proper curing such as:

- industrial flooring;
- parking:
- warehouses;
- hydraulic structures subject to cavitation or solid transport;
- beams and pillars;
- structure in general.

FEATURES AND BENEFITS




Fig. 1 Values obtained on cement-based mortar type CEM I 52.5 R, normalized sand and water, according to composition indicated in standard EN 196-1




Fig. 2 Values obtained on cement-based mortar type CEM I 52.5 R, normalized sand and water, according to composition indicated in standard EN 196-1

MasterEmaco A 400 has the property of overall decreasing the surface tension of the water enclosed in the capillary porosities in the matrix. This results in a lower attractive force between the walls of the capillary pores and consequently a lower hydraulic shrinkage. MasterEmaco A 400 is therefore used to improve air expansion in the absence of wet maturation, a condition not always achievable on site (Figure 1). This quarantees the reduction of plastic and hygrometric shrinkage and, consequently, the formation of microcracks and fissures (figure 2). In this way it is possible on the one hand to reach problems of imperfections of the products, on the other hand, by reducing the formation of micro-cracks, it allows to install a mortar or concrete more resistant to the action of degradation by aggressive agents, chlorides, sulphates, carbon dioxide, coming from outside.

The addition of MasterEmaco A 400 reduces warping phenomena and allows greater maintenance of workability in summer climates.

MasterEmaco A 400, depending on the dosage, like all additives in this category, can reduce mechanical performance:

CONSUMPTION

Minimum dosage: 0.25% on the weight of the powder. Different dosages are possible in relation to the specific working conditions, and in any case after consulting the technical staff of Master Builders Solutions Italia Spa.

PACKAGING

MasterEmaco A 400 is available in 5 kg canister.

STORAGE

Store the product in a dry and sheltered place at a temperature anywhere between 5 and +35°C.

APPLICATION

MasterEmaco A 400 is a ready-to-use liquid that is introduced during the mixing phase of the cement mixture (minimum dosage: 0.25% of the weight of the powder) after having loaded and amalgamated all the other ingredients.

Mix until a homogeneous mixture is obtained.
